1. Introduction

This policy aims to show our commitment to meeting our obligations with regards to school attendance, including those laid out in the Department for Education's (DfE's) statutory guidance on [working together to improve school attendance \(applies from 19 August 2024\)](#), through our whole-school culture and ethos that values good attendance, including:

- Setting high expectations for the attendance and punctuality of all pupils
- Promoting good attendance and the benefits of good attendance
- Reducing absence, including persistent and severe absence
- Ensuring every pupil has access to the full-time education to which they are entitled
- Acting early to address patterns of absence
- Building strong relationships with families to make sure pupils have the support in place to attend school

We will also promote and support punctuality in attending lessons.

The Constellation Trust seeks to ensure that all pupils receive a fulltime education which maximises opportunities for each of them to realise their true potential. The Constellation Trust will strive to provide a welcoming, caring environment, whereby each member of the individual schools' community feels valued and secure.

At the core, lies an expectation that pupils will come to their school regularly and on time. All our staff will work with pupils and their families to support parents/guardians in helping them meet their legal duty to ensure that their children attend school regularly and on time.

The attendance policy and practice will ensure that children are kept safe and ensure their welfare needs are met in accordance with current safeguarding practice.

2. Legislation and guidance

This policy is based on the Department for Education's (DfE's) statutory guidance on [working together to improve school attendance \(applies from 19 August 2024\)](#) and [school attendance parental responsibility measures](#). This policy also complies with our trust's funding agreement and articles of association.

3. Roles and responsibilities

3.1 **The Board of Trustees and the school's Local Advisory Board** are responsible for:

- › Setting high expectations of all school leaders, staff, pupils and parents
- › Making sure school leaders fulfil expectations and statutory duties, including:
 - Making sure the school records attendance accurately in the register, and shares the required information with the DfE and local authorities
 - Making sure the school works effectively with local partners to help remove barriers to attendance, and keeps them informed regarding specific pupils, where appropriate
- › Recognising and promoting the importance of school attendance across the school's policies and ethos
- › Making sure the school's attendance management processes are delivered effectively, and that consistent support is provided for pupils who need it most by prioritising staff and resources
- › Making sure the school has high aspirations for all pupils, but adapts processes and support to pupils' individual needs
- › Regularly reviewing and challenging attendance data and helping school leaders focus improvement efforts on individual pupils or cohorts who need it most
- › Working with school and Trust leaders to set goals or areas of focus for attendance and providing support and challenge
- › Monitoring attendance figures for the whole school and repeatedly evaluating the effectiveness of the school's processes and improvement efforts to make sure they are meeting pupils needs
- › Where the school is struggling with attendance, working with school leaders to develop a comprehensive action plan to improve attendance
- › Making sure all staff receive adequate training on attendance, including with teachers from across the trust, as part of the regular continued professional development offer, so that staff understand:
 - The importance of good attendance
 - That absence is almost always a symptom of wider issues

- The school's legal requirements for keeping registers
 - The schools strategies and procedures for tracking, following up on and improving attendance, including working with partners and keeping them informed regarding specific pupils, where appropriate
- Making sure dedicated training is provided to staff with a specific attendance function in their role, including in interpreting and analysing attendance data
 - Sharing effective practice on attendance management and improvement across the trust and providing regular opportunities for staff from different schools to come together, learn from each other and share resources
 - Holding the Head of School to account for the implementation of this policy
 - Board of Trustees: Identifying and monitoring attendance patterns across the trust's schools to identify common issues and barriers, and share effective practice between schools

Governor for our link attendance partner - TBC.

3.2 The Head of School

The Head of School is responsible for:

- The implementation of this policy at the school
- Monitoring school-level absence data and reporting it to governors
- Supporting staff with monitoring the attendance of individual pupils
- Monitoring the impact of any implemented attendance strategies
- Issuing fixed-penalty notices, where necessary in consultation with Trust Exec Lead: Pastoral Care and/or the LA Senior Education Welfare Officer for their locality
- Working with the parents of pupils with special educational needs and/or disabilities (SEND) to develop specific support approaches for attendance for pupils with SEND, including where school transport is regularly being missed, and where pupils with SEND face in-school barriers
- Communicating with the local authority when a pupil with an education, health and care (EHC) plan has falling attendance, or where there are barriers to attendance that relate to the pupil's needs
- Communicating the school's high expectations for attendance and punctuality regularly to pupils and parents through all available channels

3.3 The Trust Exec Lead; Pastoral Care is responsible for:

- Driving attendance improvement across the trust
- Working more intensively with schools who require support to improve attendance
- Acting as a central contact point for schools with attendance queries

3.4 The Designated Senior Leader responsible for attendance

The designated senior leader (David Gordon) is responsible for:

- Leading, championing and improving attendance across the school
- Setting a clear vision for improving and maintaining good attendance
- Evaluating and monitoring expectations and processes
- Having a strong grasp of absence data and oversight of absence data analysis
- Regularly monitoring and evaluating progress in attendance
- Establishing and maintaining effective systems for tackling absence, and making sure they are followed by all staff

- Liaising with pupils, parents/carers and external agencies, where needed
- Building close and productive relationships with parents to discuss and tackle attendance issues
- Creating intervention or reintegration plans in partnership with pupils and their parents/carers
- Delivering targeted intervention and support to pupils and families

3.5 The school Attendance Team consists of:

- Assistant Head Teacher (Senior Leader)
- Two Attendance Officers
- Education Welfare Officer
- Home School Liaison Officer
- Engagement Officer

The school Attendance Team are responsible for:

- Monitoring and analysing attendance data (see section 7)
- Benchmarking attendance data to identify areas of focus for improvement
- Providing regular attendance reports and concerns about attendance to the designated senior leader responsible for attendance
- Working with education welfare officers to tackle persistent absence
- Advising the headteacher/ designated senior leader (authorised by the headteacher) when to issue fixed-penalty notices

3.6 Class teachers

All teachers are responsible for recording attendance for both morning 8.45am (Lesson One) and afternoon 11.25am (Lesson Four) sessions on a daily basis, using the correct codes (see Appendix 1), and submitting this information via Ed:Gen.

3.7 The school administration staff

The school administration staff will:

- Take calls from parents/carers about absence on a day-to-day basis and record it on the school system
- Transfer calls from parents/carers to the Attendance Team, Year Leaders and Assistant Year Leaders, and/or Safeguarding, where appropriate, in order to provide them with more detailed support on attendance

3.8 Parents

Where this policy refers to a parent, it refers to the adult the school and/or local authority decides is most appropriate to work with, including:

- All natural parents, whether they are married or not
- All those who have parental responsibility for a child or young person
- Those who have day-to-day responsibility for the child (i.e. lives with and looks after them)

Parents are expected to:

- Make sure their child attends every day on time
- Call the school to report their child's absence before 8.30am on the day of the absence (and each subsequent day of absence), and advise when they are expected to return
- Provide the school with more than 1 emergency contact number for their child, this will be collated on admission. However, school needs to be informed of any changes

- Ensure that, where possible, appointments for their child are made outside of the school day
- Keep to any attendance strategies and intervention agreed in ATTEND meetings that they make with the school and/or local authority
- Seek support, where necessary, for maintaining good attendance, by contacting the Attendance Team, Year Leaders and Assistant Year Leaders, and/or Safeguarding, who can be contacted via their direct numbers or e-Mail addresses, or using the MyEd app to communicate with the academy

3.9 Pupils

Pupils are expected to:

- Attend school every day, on time
- Attend every timetabled session, on time
- Call the school to report their absence before 8.30am on the day of the absence and each subsequent day of absence (Sixth Form students only)

4. Recording attendance

4.1 Attendance register

We will keep an electronic attendance register and place all pupils onto this register.

We will take our attendance register at the start of the first session of each school day and once during the second session. It will mark, using the appropriate national attendance and absence codes from the School Attendance (Pupil Registration) (England) Regulations 2024, whether every pupil is:

- Present
- Attending an approved off-site educational activity
- Absent
- Unable to attend due to exceptional circumstances

Any amendment to the attendance register will include:

- The original entry
- The amended entry
- The reason for the amendment
- The date on which the amendment was made
- The name and position of the person who made the amendment

See Appendix 1 for the DfE attendance codes.

We will also record:

- Whether the absence is authorised or not
- The nature of the activity, where a pupil is attending an approved educational activity
- The nature of circumstances, where a pupil is unable to attend due to exceptional circumstances

We will keep every entry on the attendance register for 6 years after the date on which the entry was made.

The school day starts at 8.30am and ends at 3.00pm (Year 7) and 3.05pm (Years 8, 9, 10 and 11)

Pupils must arrive in school by 8.30am on each school day.

The register for the first session will be taken at 8.30am and will be kept open until 8.45am. The register for the second session will be taken at 11.25am and will be kept open until 11.40am

Procedures for power or network failure

Should the school network or internet is disrupted, manual attendance registers will be used for either/ or morning and afternoon session. Completed registers will be returned to the Attendance Team office and uploaded once the issue has been resolved.

4.2 Unplanned absence

The pupil's parent must notify the school of the reason for the absence on the first day of an unplanned absence by 8.30am, or as soon as practically possible, by calling the school Attendance Team, who can be contacted via (01482) 975555 or using the academy MyEd app.

We will mark absence due to physical or mental illness as authorised unless the school has a genuine concern about the authenticity of the illness.

When there are doubts about the authenticity of the illness, the school will ask for medical evidence, such as a doctor's note, prescription, appointment card or other appropriate form of evidence. We will not ask for medical evidence unnecessarily.

If the school is not satisfied about the authenticity of the illness, the absence will be recorded as unauthorised and parents will be notified of this in advance.

4.3 Planned absence

Attending a medical or dental appointment will be counted as authorised if the pupil's parent/carer notifies the school in advance of the appointment.

However, we encourage parents/carers to make medical and dental appointments out of school hours where possible. Where this is not possible, the pupil should be out of school for the minimum amount of time necessary.

The pupil's parent/carer must also apply for other types of term-time absence as far in advance as possible of the requested absence. Go to section 5 to find out which term-time absences the school can authorise.

Part time timetables

All pupils of compulsory school age are entitled to a full-time education suitable to their age, aptitude, and special educational needs. Only in an exceptional circumstance, where it is in the pupil's best interest, would a part time timetable be considered.

This intervention should not be used as an approach to manage a pupil's behaviour.

If a school is considering a part time timetable, it must have ensured it has the agreement of both school and the parent/s the pupil normally lives with.

The Designated Safeguarding Lead will have been consulted to ensure the ongoing safeguarding of any pupil whilst on a part time timetable.

If a part time timetable is authorised, the school must notify the Local Authority using the appropriate documentation. There is also an expectation that if the pupil has a social worker they will be kept informed during the process.

4.4 Lateness and punctuality

A pupil who arrives late:

- Before the register has closed will be marked as late, using the appropriate code
- After the register has closed will be marked as absent, using the appropriate code

4.5 Following up unexplained absence

Where any pupil we expect to attend school does not attend, or stops attending, without reason, the school will:

- Call the pupil's parent on the morning of the first day of unexplained absence to ascertain the reason. If the school cannot reach any of the pupil's emergency contacts, the school may conduct a home visit

- Identify whether the absence is approved or not
- Identify the correct attendance code to use and input it as soon as the reason for absence is ascertained – this will be no later than 5 working days after the session(s) for which the pupil was absent
- Inform all parents when absence is unauthorised, this may include absence when a reason has been provided
- Call the parent on each day that the absence continues without explanation, to make sure proper safeguarding action is taken where necessary. If absence continues, the school will consider involving an education welfare officer
- Generate a Home Visit Log each day to pursue students with regular absence or those without explanation
- If relevant, report the unexplained absence to other multi agencies e.g. the pupil's youth offending team officer, social worker
- Where appropriate, offer support to the pupil and/or their parents to improve attendance
- Identify whether the pupil needs support from wider partners, as quickly as possible, and make the necessary referrals
- Where support is not appropriate, not successful, or not engaged with: issue a notice to improve, penalty notice or other legal intervention (see section 5.2 below), as appropriate

4.6 Reporting to parents

- Individual student attendance available for all parents on their MyEd app
- Individual attendance letters issued to all parents and carers at the end of every Half-Term. This provides parents and carers with the opportunity to compare their child's current attendance with that of their peers
- Half-Termly letters differ based on an individual's attendance. This enables the academy to encourage improvement or reward regular attendance
- Unauthorised letters sent to parents at 10, 15 and 20 UAs
- Unauthorised absence messages sent at the end of every day where unauthorised absence has been recorded
- Weekly 100% attendance messages sent to parents and carers to celebrate success
- Monday and Friday absence reminders to those with a pattern of regular absence
- Attendance a key focus in all academic reviews and parents evenings
- Bespoke attendance letters to reflect current issues and provide immediate support

5. Authorised and unauthorised absence

5.1 Approval for term-time absence

The Head of School will allow pupils to be absent from the school site for certain educational activities, or to attend other schools or settings.

The Head of School will only grant a **leave of absence** to a pupil during term time if the request meets the specific circumstances set out in the [2024 school attendance regulations](#). These circumstances are:

- Taking part in a regulated performance, or regulated employment abroad
- Attending an interview
- Study leave

- A temporary, time-limited part-time timetable
- Exceptional circumstances

The Head of School may not grant any leave of absence, including those for holidays, to pupils during term time unless they consider there to be 'exceptional circumstances'.

It should be noted that leave of absence is not a parental right.

The Trust defines 'exceptional circumstances' (for leave of absence that are not holiday) as 'being of unique and significant to the child's emotional, educational or spiritual well-being that it outweighs the loss of teaching time'.

The Trust will not authorise term time holidays unless there are exceptional circumstances. This will be extremely rare, and any requests must be made in writing, to the The Head of School in advance.

The school considers each application for term-time absence individually, taking into account the specific facts, circumstances and relevant context behind the request. A leave of absence is granted entirely at the The Head of School discretion.

Any request should be submitted as soon as it is anticipated and, where possible, at least four weeks before the absence. The Head of School may require evidence to support any request for leave of absence.

Other valid reasons for **authorised absence** include (but are not limited to):

- Illness (including mental-health illness) and medical/dental appointments (see sections 4.2 and 4.3 for more detail)
- Religious observance – where the day is exclusively set apart for religious observance by the religious body to which the pupil's parent(s) belong (s). If necessary, the school will seek advice from the parent's religious body to confirm whether the day is set apart
- Parent(s) travelling for occupational purposes – this covers Roma, English and Welsh gypsies, Irish and Scottish travellers, showmen (fairground people) and circus people, bargees (occupational boat dwellers) and new travellers. Absence may be authorised only when a traveller family is known to be travelling for occupational purposes and has agreed this with the school, but it is not known whether the pupil is attending educational provision
- If the pupil is currently suspended or excluded from school (and no alternative provision has been made)

Other reasons the school may allow a pupil to be absent from the school site, which are not classified as absences, include (but are not limited to):

- Attending an offsite approved educational activity, sporting activity or visit or trip arranged by the school
- Attending another school at which the pupil is also registered (dual registration)
- Attending provision arranged by the local authority
- Attending work experience
- If there is any other unavoidable cause for the pupil not to attend school, such as disruption to travel caused by an emergency, a lack of access arrangements, or because the school premises are closed

5.2 Sanctions

Our school will make use of the full range of potential sanctions – including, but not limited to, those listed below – to tackle poor attendance. Decisions will be made on an individual, case-by-case basis.

Penalty notices

The Head of School (or someone authorised by them), local authority or the police can fine parents for the unauthorised absence of their child from school, where the child is of compulsory school age, by issuing a penalty notice.

If the school issues a penalty notice, it will check with the local authority before doing so and send it a copy of any penalty notice issued.

Before issuing a penalty notice, the school will consider the individual case, including:

- Whether the national threshold for considering a penalty notice has been met (10 sessions of unauthorised absence in a rolling period of 10 school weeks)
- Whether a penalty notice is the best available tool to improve attendance for that pupil
- Whether further support, a notice to improve or another legal intervention would be a more appropriate solution
- Whether any obligations that the school has under the Equality Act 2010 make issuing a penalty notice inappropriate

Each parent who is liable for the pupil's offence(s) can be issued with a penalty notice, but this will usually only be the parent/parents who allowed the absence.

The payment must be made directly to the local authority, regardless of who issues the notice. If the payment has not been made after 28 days, the local authority can decide whether to prosecute or withdraw the notice.

If issued with a **first** penalty notice, the parent must pay £80 within 21 days, or £160 within 28 days.

If a **second** penalty notice is issued to the same parent in respect of the same pupil, the parent must pay £160 if paid within 28 days.

A **third** penalty notice cannot be issued to the same parent in respect of the same child within 3 years of the date of the issue of the first penalty notice. In a case where the national threshold is met for a third time within those 3 years, alternative action will be taken instead.

Notices to improve

If the national threshold has been met and support is appropriate, but parents do not engage with offers of support, the school may offer a notice to improve to give parents a final chance to engage with support.

Notices to improve will be issued in line with processes set out in the local code of conduct for the local authority area in which the pupil attends school.

They will include:

- Details of the pupil's attendance record and of the offences
- The benefits of regular attendance and the duty of parents under [section 7 of the Education Act 1996](#)
- Details of the support provided so far
- Opportunities for further support, or to access previously provided support that was not engaged with
- A clear warning that a penalty notice may be issued if attendance doesn't improve within the improvement period, along with details of what sufficient improvement looks like, which will be decided on a case-by-case basis
- A clear timeframe of between 3 and 6 weeks for the improvement period
- The grounds on which a penalty notice may be issued before the end of the improvement period

6. Strategies for promoting attendance

The school's strategies for rewarding and improving attendance include:

- Individual attendance letters issued to all parents and carers at the end of every Half-Term.
- Regular rewards and incentives for an individual or Lesson One Group;
 - Lesson One Group of the Month
 - Attendance Leagues
 - 100% Weeks

- Friday 100% Draws
 - Attendance Disco's
 - Persistent Absentee Trackers
 - Attendance Monitoring Groups
 - Free Breaktime Snack Vouchers
 - Staff contribution rewards
- Unauthorised letters sent to parents at 10, 15 and 20 UAs
 - Fortnightly Persistent Absentee Meetings. Key staff to contribute
 - Attendance features predominantly in Staff Training Days and weekly Staff Briefings
 - Monday and Friday-only absence pattern trackers
 - Year 11 absence list generated every morning at 8.45am. Immediate action and calls
 - Daily absence list generated every morning at 10.30am. Year Teams and their Attendance Link to pursue with contact
 - Attendance a key focus in all academic reviews and parents evenings

7. Supporting pupils who are absent or returning to school

7.1 Pupils absent due to complex barriers to attendance

In working with the Local Authority's locality attendance teams Sirius Academy West will be guided by elements of the ATTEND framework. Many/Some of our pupils arrive with a history of low attendance and a complex multifaceted barriers for example family circumstances, socio-economic challenges and mental health issues.

The ATTEND framework provides a structure methodology to help address these challenges and can help support the schools graduated response.

This will include the views of:

1. educational professionals working within a local authority's children's workforce
2. pupils
3. parents or carers

7.2 Pupils absent due to mental or physical ill health or SEND

Where a pupil has an education health and care (EHC) plan and their attendance falls, or the school becomes aware of barriers to attendance that related to the pupil's needs, the school will inform the local authority.

7.3 Pupils returning to school after a lengthy or unavoidable period of absence

Individual meetings with the student, and their parent or carer, to identify strategies to maximise success. Consideration into timetable, classes, movement around the building, start and finish times, etc.

8. Attendance monitoring

8.1 Monitoring attendance

The Trust will monitor attendance and absence data (including punctuality) half-termly, termly and yearly across each school and at an individual pupil, year group and cohort level. Monitoring of codes will also take place.

Sirius Academy West will monitor attendance and absence data (including punctuality) relentlessly on a daily and weekly basis. Reports and analysis will focus on individuals, specific cohorts and Year Groups. All will be shared with key staff to ensure the profile of attendance remains high. This will include:

- Weekly attendance reports and summaries.
- Comparisons with previous data to highlight improvement and regression
- Comparisons with National and Local data
- Fortnightly Persistent Absentee Meetings. Key staff to contribute
- Monday and Friday-only absence pattern trackers
- Analysis of Attendance Monitoring Cohorts. Students identified based on previous attendance. All allocated a member of staff for additional monitoring and scrutiny
- Analysis of daily and weekly Attendance Call Logs
- Review of 10, 15 and 20 UA students, communication with parents, completion of the ATTEND Framework, and their NTI status.

Specific pupil information will be shared with the DfE on request.

The school has granted the DfE access to its management information system so that data can be accessed regularly and securely.

Data will be collected each term and published at national and local authority level through the DfE's school absence national statistics releases. The underlying school-level absence data is published alongside the national statistics.

The school will benchmark its attendance data at whole school, year group and cohort level against local, regional, and national levels to identify areas of focus for improvement and share this with the governing board.

8.2 Analysing attendance

The school will:

- Analyse attendance and absence data regularly to identify pupils, groups or cohorts that need additional support with their attendance
- Identify pupils whose absences may be a cause for concern, especially those who demonstrate patterns of persistent or severe absence
- Conduct thorough analysis of half-termly, termly, and full-year data to identify patterns and trends
- Look at historic and emerging patterns of attendance and absence, and then develop strategies to address these patterns
- The Trust will identify attendance patterns across the trust to identify common issues and barriers and share effective practice between schools

8.3 Using data to improve attendance

Sirius Academy West will:

- Develop targeted actions to address patterns of absence (of all severities) of individual pupils, groups or cohorts that it has identified via data analysis
- Provide targeted support to the pupils it has identified whose absences may be a cause for concern, especially those who demonstrate patterns of persistent or severe absence, and their families (see section 8.4 below)

- Provide regular attendance reports to all staff to facilitate discussions with pupils and families, and to the governing board and school leaders (including special educational needs co-ordinators, designated safeguarding leads and pupil premium leads)
- Use data to monitor and evaluate the impact of any interventions put in place in order to modify them and inform future strategies
- Share information and work collaboratively with other schools in the area, local authorities and other partners where a pupil's absence is at risk of becoming persistent or severe, including keeping them informed regarding specific pupils, where appropriate

8.4 Reducing persistent and severe absence

Persistent absence is where a pupil misses 10% or more of school, and severe absence is where a pupil misses 50% or more of school. Reducing persistent and severe absence is central to the trust and school's strategy for improving attendance.

The [trust and school] will:

- Use attendance data to find patterns and trends of persistent and severe absence
- Consider potential safeguarding issues and, where suspected or present, address them in line with Keeping Children Safe in Education
- Hold regular meetings with the parents of pupils who the school (and/or local authority) considers to be vulnerable or at risk of persistent or severe absence, or who are persistently or severely absent, to:
 - Discuss attendance and engagement at school
 - Listen, and understand barriers to attendance
 - Explain the help that is available
 - Explain the potential consequences of, and sanctions for, persistent and severe absence
 - Review any existing actions or interventions
- Provide access to wider support services to remove the barriers to attendance, in conjunction with the local authority, where relevant
- Consider alternative support that could be put in place to remove any barriers to attendance and re-engage these pupils. In doing so, the school will sensitively consider some of the reasons for absence
- Implement sanctions, where necessary (see section 5.2, above)

9. Monitoring arrangements

This policy will be reviewed as guidance from the local authority and/or DfE is updated, and as a minimum of 1 year by the Assistant Head Teacher responsible for Attendance. At every review, the policy will be approved by the full board of trustees and shared with the school's Local Advisory Board.
