Secondary School Admissions 2027/28

**Consultation to change Sirius Academy West Admissions Policy**

**The proposed changes would be effective from September 2027**

**Consultation dates: 07th November 2025- 19th December 2025**

## 1. The proposals

Decrease the Published Admission Number (PAN) from 290 to 220.

This would mean that Sirius Academy West would take 220 students into Year 7 in September 2027 and all subsequent years. A PAN of 220 would be sufficient to meet the demand for places and to allow the school to focus on improving outcomes for all learners. However, we are committed to working with the authority to admit all students who have submitted a preference for Sirius Academy West where the number of applications exceed the published admission number of 220. This applies to 2027 admissions and Year 7 admissions in subsequent years

**All students currently in the Academy would be unaffected. The proposed change will not affect the current pupils or those who choose to accept an offer for a Year 7 place in September 2026. The admissions criteria for September 2027 will accept all applications from Rokeby Park Primary School** all other admissions arrangements, and oversubscription criteria, will not change. The current admissions policy can be viewed on the school's website.

## 2. Reason for change:

The proposed change will manage the financial impact of lowering demand due to declining birth rates. The change will provide stability, which will help align teaching, learning and resource allocation for the benefit of the Academy community and students currently within the Academy. The Trust and staff are working hard to continue to improve the outcomes of all our pupils and feel strongly that the proposed reduction will benefit future outcomes for our young learners, whilst still enabling us to meet the demand of places. Reducing the PAN will assist the Trust to provide stability in its long-term planning and allow the school to secure high-quality educational outcomes for the pupils currently on our roll, while continuing to provide an appropriate number of places for future pupil numbers in line with demand in the local area.
